Approval of Agenda

Mr. Blakeslee moved, Dr. Miller seconded to approve the agenda as presented.

Roll Call Vote: Blain Blakeslee, David Fox, Stephen Gilbert, Brian Gregor, Douglas Hopson, Lori Lewis, Barbara Miller, David Robinson and George Trauner voted yes. Motion carried.

Election of President Pro-Tem

Mr. Trauner asked for nominations for President Pro-Tem. Dr. Miller nominated Mr. Trauner, seconded by Mr. Gregor.

Mr. Blakeslee moved to close the nominations, seconded by Mr. Robinson. Motion carried unanimously.

Mr. Blakeslee made a motion to appoint Mr. Trauner as President Pro-Tem for the remainder of the meeting. Dr. Miller seconded the motion. Motion carried unanimously.

Mr. Trauner announced he would preside as President Pro-Tem for the remainder of the Reorganization meeting.

Prior to election for the President and Vice President, Mr. Trauner announced the following:

1. The affirmative vote of the majority of the members present is required for the office of President and Vice President. Tonight with nine board members present, the office of President and Vice President will require five affirmative votes.
2. According to Board policy #9348, these will be in rotating alphabetical order.
3. Seconds are not required for the nomination of the election of President and Vice President but are permitted.
4. No abstentions are permitted.

There were no questions.

Election of President – one-year term

Mr. Trauner opened the floor for nominations for the office of President of the Union City Area School District Board of Directors who would serve for a one-year term. Mrs. Lewis nominated Mr. Trauner, seconded by Dr. Miller.

Being no other nominations, Mr. Robinson moved the nominations be closed, seconded by Mrs. Lewis. Motion carried unanimously to close the nominations.

Mr. Trauner asked for a motion to nominate himself, George Trauner, as President of the Union City Area School District Board of Directors for a one-year term. Mr. Blakeslee moved, Dr. Miller seconded. The motion carried unanimously.

Mr. Trauner announced that he would serve as the President of the Union City Area School District Board of Directors for a one-year term.

Election of Vice President – one-year term

Mr. Trauner asked for nominations for the Vice President of the Union City Area School District Board of Directors who would serve for a one-year term. Dr. Miller nominated Mrs. Lewis, seconded by Mr. Blakeslee. Mr. Gilbert nominated Mr. Gregor, seconded by Mr. Hopson. Being no other nominations, Mr. Blakeslee moved that the nominations be closed, seconded by Mr. Robinson. The motion carried unanimously to close the nominations.

Mr. Trauner announced that Mrs. Lewis and Mr. Gregor had been nominated as Vice President of the Union City Area School District Board of Directors for a one-year term. Mr. Blakeslee, Mr. Gregor, Mrs. Lewis, Dr. Miller, Mr. Robinson, and Mr. Trauner voted for Mrs. Lewis. Mr. Fox, Mr. Gilbert and Mr. Hopson voted for Mr. Gregor. Ms. Sill indicated that Mrs. Lewis received six votes and Mr. Gregor received three votes.

Mr. Trauner announced that Mrs. Lori Lewis would serve as Vice President of the Union City Area School District Board of Directors for a one-year term.
